Are you a Young Carer/ Young Adult Carer?

Midlothian Young Carers Project (MYCP) supports young people aged 5-25 years who care for a family member or relative experiencing:

- a disability
- III health
- a mental health condition
- Substance use



MYCP, in conjunction with VOCAL Carers Centre, are here to ensure that all carers:

- Are identified and supported up to the age of 25 and beyond.
- Are offered a Young Carers Statement/ Adult Carer Support Plan to support them and their loved ones whilst achieving their own goals.
- Are supported for tuition, swimming and bike riding.
- Access the right information and advice at the time of need through our 1-1 meetings, drop ins and awareness raising events.
- Have opportunities for respite and breaks from their caring role- all throughout the year including school holidays.

Housing Service Performance Scottish Housing Regulator's, Regulatory Framework:



Each year social landlords need to tell us if they meet the regulatory standards and requirements. They do this by submitting an Annual Assurance Statement (Statement). Each landlord should confirm in its Statement its level of compliance with all of the relevant requirements at www.housingregulator.gov.scot/for-landlords/regulatory-framework/#section-3.

Where a landlord does not fully comply, it should set out in the Statement how and when it will make the necessary improvements to ensure compliance.

* Are you ready for winter?
